- ◆ Applicant must attend at least three local general meetings/events in 2018.
- ◆ Applicant must be an active member of an IREM<sup>®</sup> committee or will commit to becoming an active IREM<sup>®</sup> committee member.
- ◆ Applicant must be current on membership dues as of application deadline.
- ◆ Applicant's past involvement with the chapter may be considered.

All completed applications (including a copy of your current resume) must be received at the IREM<sup>®</sup> Minnesota Chapter 45 office (see below), no later than Friday, October 20, 2017 and applicant is responsible to verify receipt of their application with Jenna Berge before the deadline. The decision of the Scholarship Award Committee is final.
